

ENVIRONMENTAL PERFORMANCE REPORT FINANCIAL YEAR 2024

The issues of environmental relevance to be reviewed for the year 2024 are as follows:

- 1) Legal compliance with **environmental regulations as a basic principle**
- 2) Correct **identification and assessment of legal requirements**
- 3) Robust segregation and **waste management** policies
- 4) Excellent **order and cleanliness** in both production plants
- 5) Inclusion of **sustainable development goals** in the management system
- 6) Operating and correctly running a **photovoltaic solar installation with a nominal power of 90.00 kw for self-consumption** at the Montcada i Reixac plant. in **2024**, we have successfully produced **18.74% of the total energy we consume ourselves**.
- 7) Operating and correctly running a facility with **5 charging points for electric vehicles** at the Montcada i Reixac plant, with a nominal power of 44.00 kw
- 8) Calculating our carbon footprint for scopes 1 and 2, the first value obtained being **€0.86 tco2e/million**. during the period 2024-2030 **it will be reduced by 1% per year** compared to the preceding year to achieve a **target of €0.80 tco2e/million**.
- 9) Renewal of **imprim'vert certification** for another three-year period (2024-2027). the aim of this french certification is to encourage companies engaged in printing activities to implement specific actions in order to reduce the impact of their activity on the environment (good management of hazardous waste, good storage of raw materials for hazardous liquids, non-use of toxic products, monitoring energy consumption and environmental awareness)
- 10) Renewal of the certificate of **environmental practices of the guild of industry and graphic communication of catalonia** for another three-year period (2024-2027).
- 11) Efficiency in **natural resource management**: we have reduced our water consumption at the Montcada i Reixac plant by **5.83%** and by **18.75%** at the Montornès del Vallès plant, compared to the preceding years. this is due to our policy of implementing automatic closure mechanisms and raising awareness about the proper use of natural resources
- 12) Efficiency in **natural resource management**: we have reduced by **3%** the consumption of **electricity** at the Montcada i Reixac plant as a result of our policy regarding bringing online the photovoltaic solar installation mentioned in section 6) of this report
- 13) Efficiency in **natural resource management**: we have installed a new active harmonic filter in the **capacitor bank** of the Montcada i Reixac plant, to improve energy efficiency and correctly compensate for reactive energy
- 14) Efficiency in **natural resource management**: we have replaced **air conditioning (hot / cold)** units at the Montcada i Reixac plant for more efficient and low-consumption ones
